SUPERINTENDENT'S REPORT: Update on Strategic Plan for April-June was given. Continued assessment of health and safety. HS will have the current ISD social worker 5 days a week. The ES is still looking at how many days the ISD will provide a social worker. ALICE and threat assessment training will continue by Phil Stark. Series 3 bond work will begin next year with the purchase of 3 new propane buses and a new phone system for the district. We will also be focusing on cyber security assessment and training as well as a replacement cycle for technology.
