Motion by Terakedis to accept the recommendation of the administration to award the BreadBid for the 2021-22 School Year to Aunt Millie's Bakeries. Seconded by Williams. Motion carried 6-0.

Motion by Williams to accept the recommendation of the administration to award the Fuel Bid (Diesel and Propane) for the 2021-22 School Year to Crystal Flash. Seconded by Reynolds. Motion carried 6-0.

Superintendent's Report: Superintendent Head reviewed the current construction projects, delays, and timeframes. Paving at the Board of Education Office and Middle School should occur this week, and the High School lot will follow. Bleachers are wrapping up. Painting and

bathrooms in the Bishop Building are complete. Sports are kicking off this week. There will be a staff breakfast on August 23rd, 2021 at 7:30 am; board members are invited to attend.
